INTERNATIONAL TRAVEL EDUCATION PROGRAM AGREEMENT

Materials include a description of the overall program, program costs and fees, payment plans, payment deadlines, eligibility requirements, course enrollment requirements, refund policies, passport requirements, and all other related topics. Per this agreement and the letter of acceptance, Participants are required to (1) read all materials and communications and be bound by them, (2) attend a mandatory pre-departure meeting, (4) adhere to the payment schedules.

International Travel Education reserves the right to make alterations to the program as may be necessary, consistent with the stated goals. While International Travel Education will make reasonable effort to adhere to the itinerary, activities, and costs, it may be forced to make alterations based on requirements of the host institution, currency fluctuations, flight cancellations, weather, U.S. State Department travel advisories, and other events beyond International Travel Education's control. International Travel Education and its agents shall not be liable for damages arising from circumstances beyond its control.

Should International Travel Education cancel the program, for any reason, prior to departure or after commencement, International Travel Education will make every effort to refund to the Participant any program expenses that are recoverable.

The Participant will notify International Travel Education, in writing, should Participant decide to withdraw from the program after March 15, 2025. The date this notification is received by International Travel Education will be used to calculate any possible recoverable refunds, less the \$200 non-refundable application fee. Participant will be responsible to pay for any unrecoverable program costs. Participant understands that no refunds will be given after the program's initiation.

Should Participant fail to meet any payment deadline the student may be expelled from the program and recoverable program costs will be refunded, less the \$200 deposit. Scholarship recipients may also be liable to the scholarship agency that granted the award.

Participant understands that s/he is traveling to a foreign country where they are subject to that nation's laws and customs. Participant agrees to exercise prudent care in relation to health risks, physical safety, drug/substance abuse, and political instability.

The participant understands that a COVID-19 Travel Waiver Form will be issue before travel. By signing the waiver, the participant acknowledges the contagious nature of COVID-19 and voluntarily assume the risk that may be exposed or infected by COVID-19 while traveling.
